RELEASE AND WAIVER OF LIABILITY, INDEMNITY AGREEMENT, ASSUMPTION OF RISK, AND PARENTAL CONSENT.

I acknowledge that if I and/or my minor child believe that conditions are unsafe, I and/or my minor child will immediately discontinue participation.

I fully accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my minor child incur as a result of my and/or my minor child's participation in the event.
